of the third respondent and/or the third respondent's community.

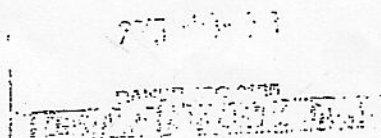

2. That it is hereby declared that the second applicant is the legitimate claimant in the land claim in respect of the subject land claimed in terms of the covering letter and claim form which are Annexures "A1" to "A9" to the applicants' founding affidavit.
3. That it is hereby declared that the first applicant is the legitimate representative of the second applicant and more particularly in the land claim of the first applicant referred to in paragraph 2 above.
4. That the first and second respondents are ordered to recognise and accept the claim of the second applicant as a separate and distinct claim from the claims of any and all other communities and/or individuals
